

HATCHET III
CAST CREDIT OBLIGATIONS

DANIELLE HARRIS

CREDIT: Provided that Performer appears recognizably in the Picture in the role of “Marybeth”, Performer shall be accorded credit on screen in the main titles (provided the principal credits appear in the main titles, otherwise in end titles) on all positive prints of the Picture on a separate card, above the title, in no less than first position. The size of type (i.e., height, width, boldness, duration) of Artist’s credit will not be less prominent, and not smaller than the credit accorded the other principal actors, director or any producer on the Picture. There are only two (2) performer credits above the title.

- a) Paid Advertising: Subject to the customary exclusions and practices of the Producer, and/or any third party distributor(s) of the Picture, guaranteed in paid advertising in connection with the Picture, about the title, in no less than FIRST position wherein any of the principal actors of the cast receive credit (i.e. billing block, artwork, title, etc). The size of type (i.e., height, width, boldness, duration) of Artist’s credit will not be less prominent, and not smaller than the credit accorded the other principal actors, director or any producer.
- b) Likeness: Subject to Artist’s approval in each instance, Artist hereby grants producer to Producer the right to use Artist’s name, approved likeness and/or approved biography (to be either submitted by or approved by Artist’s publicist) in connection with the production, exhibition, advertising, and other exploitation of the Picture and all subsidiary and ancillary rights therein, in any and all media, including, but not limited to, recordings (in any configuration) containing any material derived from the Picture, including, without limitation, the videocassette box, DVD box, artwork and packaging with respect thereto, and publications in connection with the picture; provided, however, that in no event shall Artist be depicted as using or endorsing any product, commodity or service without Artist’s prior written consent.

KANE HODDER

CREDIT: Provided that Performer appears recognizably in the Picture in the role of “Victor Crowley”, Performer shall be accorded credit on screen in the main titles (provided the principal credits appear in the main titles, otherwise in end titles) on all positive prints of the Picture on a separate card, above the title, in no less than second position. The size of type (i.e., height, width, boldness, duration) of Artist’s credit will not be less prominent, and not smaller than the credit accorded the other principal actors, director or any producer on the Picture. There are only two (2) performer credits above the title.

- a) Paid Advertising: Subject to the customary exclusions and practices of the Producer, and/or any third party distributor(s) of the Picture, guaranteed in paid advertising in connection with the Picture, about the title, in no less than SECOND position wherein any of the principal actors of the cast receive credit (i.e. billing block, artwork, title, etc). The size of type (i.e., height, width, boldness, duration) of Artist’s credit will not be less prominent, and not smaller than the credit accorded the other principal actors, director or any producer.
- b) Likeness: Subject to Artist’s approval in each instance, Artist hereby grants producer to Producer the right to use Artist’s name, approved likeness and/or approved biography (to be either submitted by or approved by Artist’s publicist) in connection with the production, exhibition, advertising, and other exploitation of the Picture and all subsidiary and ancillary rights therein, in any and all media, including, but not limited to, recordings (in any configuration) containing any material derived from the Picture, including, without limitation, the videocassette box, DVD box, artwork and packaging with respect thereto, and publications in connection with the picture; provided, however, that in no event shall Artist be depicted as using or endorsing any product, commodity or service without Artist’s prior written consent.

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture), in not less than 4th position amongst all cast members receiving credit. Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast

member. If any other below the title cast member appears in paid advertising for the Picture issued or controlled by Company Artist will also appear in no less than 4th position amongst all cast members receiving credit.

CAROLINE WILLIAMS

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture), in not less than 4th position amongst all cast members receiving credit. Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member. If any other below the title cast member appears in paid advertising for the Picture issued or controlled by Company Artist will also appear in no less than 4th position amongst all cast members receiving credit.

DEREK MEARS

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture). Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.

CODY BLUE SNIDER

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture). Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.

RILEAH VANDERBILT

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture). Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.

ROBERT DIAGO DOQUI

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture), in not less than 7th position amongst all cast members receiving credit. Such credit shall appear in a size of type not smaller than any other cast member. If any other below the title cast member appears in paid advertising for the Picture issued or controlled by Company Artist will also appear in no less than 7th position amongst all cast members receiving credit.

SEAN WHALEN

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture), in not less than 13th position amongst all cast members receiving credit. Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member. If any other below the title cast member appears in paid advertising for the Picture issued or controlled by Company Artist will also appear in no less than 13th position amongst all cast members receiving credit.

JASON TROST

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture). Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.

DIANE AYALA GOLDNER

CREDIT: On screen on all finished release prints of the Picture, in the main titles (whether located at the beginning or the end of the Picture). Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.

SID HAIG

CREDIT: On screen on all finished release prints of the Picture, in the main titles (at the end of the Picture), which will start with the actors and after a listing of approximately 15 actors we will create a gap and list Sid's credit as "And Sid Haig as Abbott MacMullin." Such credit shall be on a single card and credit shall appear in a size of type not smaller than any other cast member.
