

In front unit bathroom there was signs of moisture as indicated on the pictures, Owner to have a licensed contractor inspect & make repairs.

In the master bedroom wall their are water satins & bubbling of paint, No signs of moisture was noted @ time of inspection, however its believed that these problems in a few rooms is build up of condensation from a/c unit (as this apparently happens during prolong use of a/c units).

We recommend that the a/c unit be run for a minimum of 30 minutes before another inspection up to 1 hour to make a final determination of problem.
