The Contractor hereby grants to the Company the right to use the Contractor's name, likeness and/or biography in connection with the production, exhibition, advertising and other exploitation of the picture, including, without limitation, behind-the-scenes footage and other DVD-related materials. Notwithstanding the foregoing, the Contractor shall have the right to approve of his biography and still publicity photographs in advance, which approval shall not be unreasonably withheld.

MACLAIN NELSON

Such credits **shall** be included in the Picture's main titles. However, if all individual credits appear in the end titles, they shall be in the end titles. The Company hereby agrees to use some effort to obtain approval from the Picture's Distributor to grant the Contractor credit in paid advertising issued in connection with the Picture on one sheets, billboards, newspaper advertising of at least one quarter page and in trade ads, subject to all customary exclusions. No casual or inadvertent failure, nor failure of any third party, to give the applicable credit shall constitute a breach of this Agreement.

Name and Likeness. The Contractor hereby grants to the Company the right to use the Contractor's name, likeness and/or biography in connection with the production, exhibition, advertising and other exploitation of the picture, including, without limitation, behind-the-scenes footage and other DVD-related materials. Notwithstanding the foregoing, the Contractor shall have the right to approve of his biography and still publicity photographs in advance, which approval shall not be unreasonably withheld.

TYSON ARNOLD

Screen and Advertising Credits. Provided that the Contractor substantially renders services on the Picture as Cinematographer and is not in default of this Agreement, the Contractor shall be accorded credit on the positive prints of the Picture, on screen, in the main credits "Director of Photography - Ty Arnold" and any other camera department related credits per Contractors discretion. No paid ads are guaranteed. No casual or

inadvertent failure, nor failure of any third party, to give the applicable credit shall constitute a breach of this Agreement.

<u>Name and Likeness</u>. The Contractor hereby grants to the Company the right to use the Contractor's name, likeness and/or biography in connection with the production, exhibition, advertising and other exploitation of the picture, including, without limitation, behind-the-scenes footage and other DVD-related materials.

PANU AALTIO

Screen Credit: Composer shall receive screen credit on a single card or shared card in the main titles of the Picture as either "Music Composed by: Panu Aaltio", or "Music by Panu Aaltio," or "Original Score by Panu Aaltio" or some other variation agreed by Producer and Composer. Producer shall make reasonable efforts to guarantee Composer that Composer be recognized in the main titles of the Film, provided that Composer completes and delivers the score timely and adheres to the terms of this contract.

Paid Advertising: Producer shall make reasonable efforts to afford Composer credit as set forth above in the billing block portion of all paid advertisements issued by Producer or under Producer's control including, but not limited to, one-sheets, all manner of outdoor advertising and trailers where the Picture's Producer or Director are accorded credit subject to customary exclusions (i.e. award, nomination and congratulatory ads), except if Producer or Director are credited in such excluded ads, Composer shall also be credited. Credit as set forth above also to appear on billing block portion of all video cassettes, laser discs and DVD's wherever the Producer or Director are credited. Producer shall not be responsible for any inadvertent omission or corrections by either Producer or Distributors.

<u>Name, Image, and Likeness</u>: Composer grants the right to Producer and Producer may use Composer's name, image, and likeness to promote the Picture in all advertising, behind the scenes, and promotional material.
