

CERTIFICATE OF AUTHORSHIP

I, Daniel Myrick, hereby certify that pursuant to an Agreement ("Writer-Director Agreement") between The Objective LLC ("Production Company") and me, dated as of February 1, 2006, in connection with the motion picture project presently entitled "The Objective" (the "Picture"), all literary material of whatever kind or nature, to be written or to be furnished, by me and all of the results and proceeds of my services pursuant to said Writer-Director Agreement (all such literary material and all such results and proceeds being referred to collectively herein as the "Material") will be written by me within the scope of my employment for Production Company and shall be a "work-made-for-hire" specially ordered or commissioned by Production Company for use as part of the Picture in accordance with the U.S. Copyright Act with Production Company being deemed the author of the Material. I hereby acknowledge that Production Company, as author of the Material, is the sole and exclusive owner of all rights of every kind or nature, whether now known or hereafter devised (including, without limitation, all copyrights and all extensions and renewals of copyrights) in and to the Material, with the right to make all uses of the Material throughout the universe and all changes in the Material as Production Company deems necessary or desirable. To the extent there may be any material written or prepared by me in connection with the Picture which is not deemed to be prepared as a work-made-for-hire (which material is deemed to be part of the Material for the purposes hereof), any and all right, title and interest therein and thereto (including, without limitation, any copyright thereof) are hereby irrevocably granted and assigned to Production Company in perpetuity, and I acknowledge that the sums paid to me in connection with the Materials pursuant to the Writer-Director Agreement also constitutes consideration in full for such grant and assignment.

I hereby waive all rights of "Droit Morale" or "Moral Rights of Authors" or any similar rights or principles of law which I may now or later have in the Material. It is agreed that my consideration for the Material is included in the compensation to be paid pursuant to the Writer-Director Agreement.

I represent that I have the right to execute this document and, except to the extent that it is based upon material assigned to me by Production Company to be used as the basis therefore or is in the public domain, that the Material is or shall be original with me, to the best of my knowledge does not and shall not defame or disparage any person or entity or infringe upon or violate the rights of privacy, publicity or any other rights of any kind or nature whatsoever of any person or entity, and is not the subject of any litigation or of any claim that might give rise to litigation. I shall indemnify and hold harmless Production Company, its parent, subsidiaries, successors, licensees and assigns, and any of its or their agents, employees, officers, directors, shareholders or representatives, from and against any and all liability, judgments, claims, costs, damages, losses and expenses (including, without limitation, reasonable outside attorneys' fees and court costs, whether or not in connection with litigation) arising out of or in connection with a breach of the foregoing covenants, warranties and representations.

I agree to execute any documents and do any other acts as may be reasonably required by Production Company or its assignees or licensees to further evidence or effectuate Production Company's rights as set forth in this Certificate of Authorship or the Writer-Director Agreement. Upon my failure to do so, I hereby appoint Production Company as my attorney-in-fact for such purposes (it being acknowledged that such appointment is irrevocable and coupled with an interest) with full power of substitution and delegation.

I further acknowledge that (i) in the event of any breach hereunder by Production Company, I will be limited to my remedy at law of damages, if any, and will not have the right to terminate or rescind

the Writer-Director Agreement or this Certificate or to enjoin the distribution, advertising or exploitation of the Material or the Picture, (ii) nothing herein shall obligate Production Company to use my services or the results or proceeds thereof in the Picture or to produce, advertise or distribute the Picture, and (iii) this Certificate shall be governed by the laws of the State of California applicable to agreements executed and to be performed entirely therein.

Subject to the Writer-Director Agreement, Production Company's rights with respect to the Material and/or my services may be freely assigned and licensed and its rights shall be binding upon me and inure to the benefit of such assignee or licensee.
